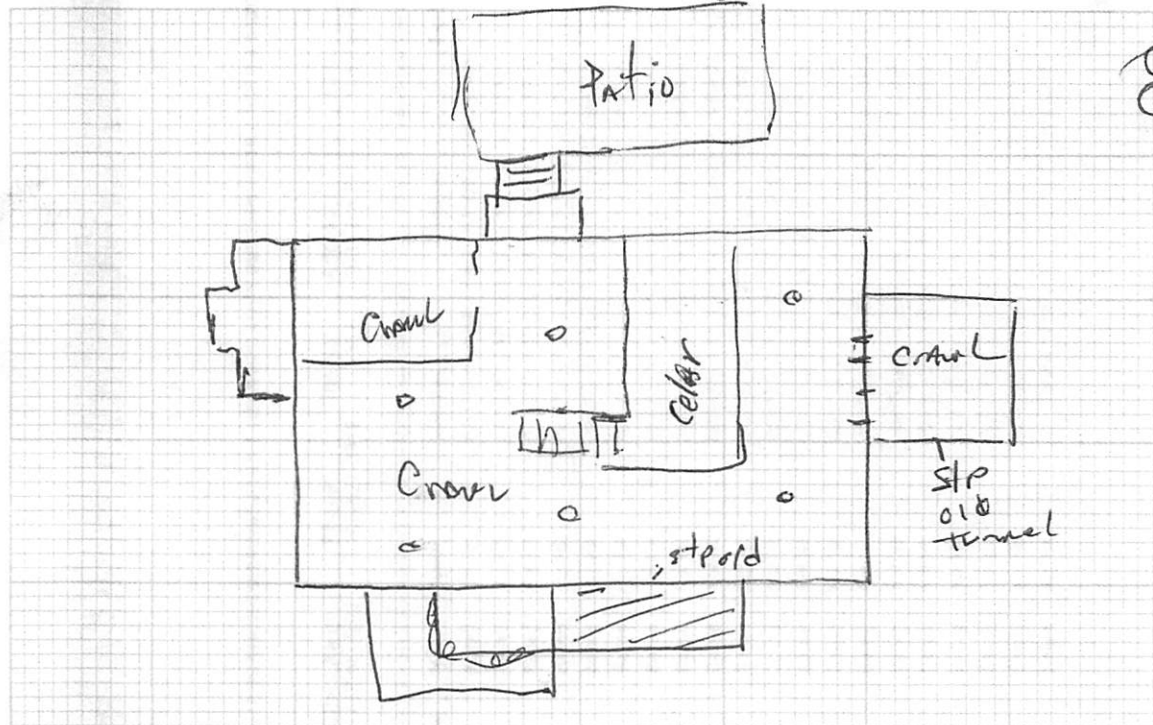

The undersigned American Pest Control, Co., hereby contracts to insulate and/or inspect the building (or buildings) listed below, against the attack and/or presence of subterranean termites in accordance with the required specifications of American Pest Control Co. and the State Agriculture Dept. **This agreement covers Subterranean Termites (Reticulitermes) Only.**

Treatment and/or contract period of one year \$ 250.00

The undersigned Company agrees that any treatment to insulate against the attack of subterranean termites found necessary upon inspection, shall be performed at no additional cost. This agreement is effective for one year from the date of the contract.

The undersigned Company agrees to inspect covered property yearly for the sum of \$ 250.00, (yearly renewal fees are fixed for one year, Company reserves right to adjust renewal fees.) payable annually on or before each anniversary of the contract. The purchaser reserves the right to terminate this agreement as of any anniversary date, by giving thirty days written notice to the undersigned Company; the undersigned Company reserves the right to terminate this agreement as of the first of any later anniversary date, unless same is terminated sooner by the purchaser.

Notify American Pest Control Co. immediately if any of the following occurs:

1. If any competitor tries to get you to cancel this contract.
2. If any competitor goes underneath or about this building.
3. If any additions to existing foundations are added (new additions must be treated).

Any of the above items, if we are not notified, could cause cancellation of this contract. After this contract has been accepted by purchaser, it is binding on both parties. Purchaser agrees to pay all collection costs including a reasonable attorney's fees.

Arbitration: Any and all disputes, controversies or claims arising out of or relating to any transaction or the construction, performance, or breach of this or any other Agreement, whether entered into prior to, on, or subsequent to the date hereof, including, but not limited to, the Buyer, the Seller, and the Pest Control Operator, including its officers and employees, shall be resolved by binding arbitration. This agreement is made pursuant to a transaction in Interstate Commerce, and shall be governed by the Federal Arbitration Act at 9 U.S.C. Section 1. The parties agree and understand that they choose arbitration instead of litigation to resolve disputes. The parties voluntarily and knowingly waive any right they have to a jury trial. In addition, any and all disputes, controversies or claims regarding whether an issue is arbitrable shall be determined by the arbitrator. The arbitration shall be conducted in accordance with the Commercial Arbitration Rules then in force by the American Arbitration Association.
